



Sri Samaveedeswarar Temple Divine abode of blessings in Thirumangalam

Location: Thirumangalam, near Trichy, Tamil Nadu, India
Significance: A sacred Devara Vaippu Sthalam and Parasurama Kshetram. Nestled in the lush landscape of Tamil Nadu, the Sri Samaveedeswarar Temple at Thirumangalam stands as a beacon of devotion and divine energy. More than 2,000 years old, this temple has a rich history and deep spiritual significance, attracting pilgrims and devotees from across the globe. It is considered equally sacred to Kasi and Gaya, two of the holiest places in India, and is believed to carry the blessings of Lord Shiva and

Goddess Loka Nayaki (the divine consort of Lord Samaveedeswarar). The temple is dedicated to Lord Samaveedeswarar (a form of Lord Shiva) and Goddess Loka Nayaki. According to legend, the temple is revered not only for its association with several historical and spiritual figures but also for its unique connection to divine stories. Thirumangalam is one of the sacred Devara Vaippu Sthalams, meaning it was sung about by Tamil saints like Sundarar, Nambiyandar Nambi, and Sekkizhar. It is also famously known as Parasurama Kshetram, as it is believed that Parasurama, the sixth incarnation of Lord Vishnu, worshipped Lord Shiva here to absolve himself of sins. Architecture The temple showcases classic Dravidian architecture. The main structure, or sanctum sanctorum, consists of several components: Sanctum (Garbhagriha) Antarala (inner hall) Artha Mandapam (vestibule) Mukha Mandapam (outer hall)

These are built at different elevated levels to enhance the spiritual experience. The Adhithana (base of the temple) is of simple Padabandha Adhithana, resting on an Upa-Peedam (secondary platform). The sanctum walls are adorned with Brahmakantha and Vishnukantha pilasters, featuring a variety of sculptural elements. Some of the famous sculptural depictions on the temple walls include scenes from the Ramayana, such as Rama and Lakshmana with Anjaneyar, and Mahishasuramardini in two panels. The Vimana (temple tower) is a Dvitala (two-tiered) structure, with the Shikaram (top) constructed in the Dravida style. The tower features Mahanasis (large niches) on the cardinal directions and Alpanasis (small niches) in between them, housing various deities. Notably, the Ganda (neck) of the Upa-Peedam is adorned with miniature sculptures from the Ramayana. Legends Thirumangalam is steeped in rich mythological stories, many of which center around devotion, redemption, and moksha.

a. Parasurama: The legendary sage, having committed the sin of matricide, worshipped Lord Shiva here to be absolved of his sin.
b. Lakshmi's Worship: It is believed that Goddess Lakshmi, the consort of Lord Vishnu, also worshipped Lord Shiva in this sacred place, leading to the name Thirumangalam (the sacred place of Mangalam, where Lakshmi found divine favor).
c. Chandikeswarar's Redemption: According to another legend, Chandikeswarar, the divine attendant of Shiva, worshipped Lord Shiva here to atone for the sin of patricide and attained moksha (liberation).
d. Jaini Munivar and the Samaveda: Jaini Munivar, a disciple of Vyasa Maharishi, is said to have divided the Samaveda into 1000 parts and prayed to Lord Shiva here. As a result, Lord Shiva came to be known as Samaveedeswarar, the Lord of the Samaveda.
e. Thiru Anayana

Brahma, and Vishnu are depicted in the Griva Koshta (niche) of the temple. Festivals The temple celebrates several major festivals with great fervour:
i. Mahashivarathri
ii. Thai Pongal
iii. Vinayagar Chaturthi
iv. Karthigai Deepam
Additionally, the Guru Pooja of Anaya Nayanar is conducted on the Hastha Nakshatra day in the month of Karthigai, honoring his devotion to Lord Shiva. Special poojas are also performed on Fridays and Pradosham days, with devotees seeking relief from their problems and seeking divine blessings for health and prosperity. Benefits Devotees flock to this temple for various spiritual and material blessings. The temple is believed to:
1) Ward off doshas related to neglecting ancestors.
2) Cure illnesses, especially through the grace of Bhairava.
3) Restore fortunes, particularly through the blessings of Saneeswarar (Lord Saturn).

Nayanar, born in Thirumangalam, was a devoted flute player and worshipped Lord Shiva with his music. His devotion was so powerful that Lord Shiva blessed him with moksha. A Swayambhu Lingam is said to have grown continuously in the place where he attained liberation, and his shrine is situated within the temple complex.
f. Creation of the Gaya Phalguni River: A Rishi named Ravikruva wanted to perform rituals for his ancestors but could not find a river. In response to his prayer, Lord Shiva created the Gaya Phalguni River, which continues to flow near the temple. Because of this, the place is equated with Gaya, a key site for performing ancestral rites. Deities The temple enshrines several powerful deities, each with a unique significance:
Moolavar (Main deity): Lord Samaveedeswarar, an extraordinary form of Lord Shiva, is enshrined in the main sanctum. The deity is believed to have appeared spontaneously under a Kondrai tree.
Ambal (goddess): Goddess Loka Nayaki, the consort of Lord Samaveedeswarar, has a separate shrine located between the second-level entrance and the sacred bull, Rishabam.
Valli Devasena Kalyana Subramaniam: A six-faced, four-armed form of Subramanya, seated on a peacock with his consorts, Valli and Deivanai.
Maha Ganapathy, Natarajar, Kala Bhairava, and Chandikeswarar are also worshipped here.

Demand to declare Tirumala airspace as no-fly zone

The flying of an aircraft over the Venkateswara Swamy temple, which is one of the richest temples in the world, here on Thursday, created a flutter. Images and videos of an aircraft hovering over the temple in Tirumala

went viral on different social media. As per Agama Shastra, aircraft, helicopters, and drones, are not permitted to fly over the sanctum sanctorum of the temple of lord Sri Venkateswara in Tirumala. The Tirumala Tirupati Devasthanams' (TTD) vigilance and security personnel expressed concern after an aircraft flew over the sanctum sanctorum of the temple of Lord Venkateswara. Despite the TTD management having earlier appealed to the Civil Aviation Ministry on several occasions to declare Tirumala as a flying zone, no positive decision has been taken by the Central Government so far, sources said. Though the Directorate General of Civil Aviation (DGCA) has not officially declared the Tirumala air space as a no-fly zone, airlines and chartered aviation companies avoid flying over the temple keeping in mind the immense religious significance of the shrine. Thus, the sighting of an aircraft flying over the temple sparked consternation and debate in the town on Thursday. Incidents of helicopters and aircraft flying over the temple airspace continue to occur. In 2012, when N. Kiran Kumar Reddy was the Chief Minister of undivided Andhra Pradesh, the state government and the TTD had requested the Centre to declare the Tirumala temple airspace as a 'no-fly zone'. In 2015, the AP government reiterated its appeal during P Ashok Gajapathi Raju's tenure as Union Civil Aviation Minister, but the DGCA turned down the request in 2016 and made it clear that the ancient hill town cannot be declared a no-fly zone.
