Plot to kill Khalistan separatist Pannun: 2 more courts to take call on Nikhil Gupta extradition, says his Prague lawyer

Municipal court has ruled in favour of US request, Czech Govt has final say

NEW DELHI

Nikhil Gupta, accused by US authorities of plotting to kill Khalistan separatist Gurpatwant Singh Pannun at the behest of an Indian intelligence official, is lodged in a prison in Prague. And while a municipal court recently has ruled in favour of his extradition to the US, Gupta can pursue legal remedies in two higher courts before the country's Ministry of decision on the extradition request, his lawyer, Petr Slepicka, told The Sunday Express.

30 this year and his extradition, as requested by the US government, is currently under consideration by the courts there.

"He is still in Prague. Justice makes a final He is currently in Pankrac prison. The municipal court has given a decision in favor of his extradition, but he (Gupta) has challenged this in the High Court.

After this, he can go to the Constitutional Court. The final decision (of extradition) rests with the Ministry of Justice," he said on the phone from Prague. Explaining the legal road ahead for Gupta, Slepicka, a member of the law firm

pal, high court, and constitutional court) issue three positive decisions in favor of extradition, the Ministry of Justice can still decide against

However, the Ministry cannot reverse three negative decisions against extradition into a positive one.. Slepicka, who has been representing Gupta in court for at least two months, told The Sunday Express that the municipal court's decision came before the second indictment filed by the US authorities on November 29. The first indictment had few details of the crime alleged by the US, and, he believes, the revelations in the second indictment help his client's case.

"You have to bear in mind that when the Municipal Court's decision had come, it was based on the first indictment filed by the US authorities, which didn't have any details of the case. Even the judges here didn't know who was the victim and what was the nature of the alleged crime. With the second indictment, we now have more details, and I think it helps his (Gupta's) case. There are political involved," he said.

Smugglers find new ways to bring in gold as price, import duties go up

surge in gold prices and high import duties on the yellow metal, multiple such instances of gold smuggling have been busted across airports in India in recent months.

Testimonies of customs and airport officials testify to the fact that the recent cases involve new innovations, such as smuggling gold in the form of paste and instances of "well-educated individuals" being involved in the trade. In 2023, according to official statistics, gold smuggling cases in the country surged over 20 per cent year-onyear till October, with 4,798 documented cases involving seizure of 3,917.52 kg of gold. This is the highest number of gold smuggling cases in at least three years, though the year-on-year surge in cases is lower than the 62.9 per cent year-on-year growth seen in the post-pandemic year of 2022, when 3,982 cases of gold smuggling were recorded involving seizure of 3,502.16 kg gold. In 2021, around 2,445

kg of gold was seized. A closer examination of the data also reveals a peculiar trend — Maharashtra has pipped the traditional top-ranking state, Kerala, to register the highest number of cases of gold smuggling and seizure of smuggled gold till October this

gold seized in Tamil Nadu; and 728 cases and 542.36 kg of gold seized in Kerala, official data shared by the government in Parliament showed.

The gold smuggling cases in Kerala in the first ten months of the year are lower than the 1,035 cases recorded in 2022.

Together these three states — Maharashtra, Tamil Nadu and Kerala accounted for over 60 per cent of the total gold smuggling cases registered in the country so far. In 2022, they accounted for a lower 52 per cent of the total gold smuggling cases. Gold smuggling in most states has already breached the levels of smuggling seen in the last three years. Telangana, Andhra Pradesh, West Bengal, Gujarat, Dadra and Nagar said.
