Kalaburagi airport gets hoax bomb threat

KALABURAGI (Karnataka), June 24 (PTI)

THE Kalaburagi airport received a bomb threat via email on Monday which turned out to be a hoax after a thorough search operation.

Bomb disposal and dog squads were immediately pressed into action on the airport premises.

Kalaburagi Police Commissioner Chethan R told PTI that the Airport Director Chilaka Mahesh received an email from an anonymous ID on Monday morning claiming that explosives have been planted inside the airport premises.

"As soon as we received information about a bomb threat email at Kalaburagi domestic airport, a bomb disposal squad was dispatched. All the passengers on the flight (which landed from Bengaluru) were de-boarded," he said.

All the airport staff and passengers were shifted to a safer place while an intensive and thorough search operation was carried out, he said.

After hours of search operation, the police declared that the threat was a hoax as no "suspicious" object was found.

2 killed as structure collapses in steel plant

BHUBANESWAR, June 24 (PTI)

TWO workers were killed and a few others injured as a mechanical structure of a private steel company collapsed and fell on them in Odisha's Dhenkanal district on Monday, a police officer said.

The mishap took place at Rungta Mines Ltd (Dhenkanal Steel Plant) located at Jhadabandha in Dhenkanal district. Soon after the incident, a rescue operation was launched.

"As per the preliminary report, two workers died and a few others were injured in the incident. Police have reached the spot and an inquiry will be conducted into the incident," Dhenkanal SP Madkar Sandeep Sampat told PTI over the phone.

The deceased workers have not yet been identified. It is suspected that the workers are from other states, police sources said.

Scuffle breaks out between 2 groups in Raj

JAIPUR, June 24 (PTI)

A SCUFFLE broke out between some youths playing cricket and others holding an RSS 'shakha' meeting at a park in Rajasthan's Bhilwara as police personnel were to control the situation.

A person was detained after a large group gathered at the spot demanding action against cult-prits, they said.

Additional police force from different police stations were deployed to pacify the protesters, they added.

"One person has been detained on the FIR registered by a member of the Hindu community. No untoward incident happened. Force has been deployed in the area to maintain law and order situation," Additional SP Vimal Singh Nehra said.

The incident happened in Bhimganj police station area where RSS volunteers were holding a 'shakha' at a park.

TN BJP delegation meets Governor, seeks CBI probe into hooch tragedy

CHENNAI, June 24 (PTI)

A BJP delegation led by its State chief K Annamalai on Monday met Tamil Nadu Governor R N Ravi, seeking a CBI probe into the Kallakurichi hooch tragedy that left 56 people dead.

In a post on 'X,' Annamalai claimed that 60 lives have been lost due to the tragedy and also urged Ravi to direct Chief Minister M K Stalin to drop his Cabinet colleague S Muthusamy, who holds the Prohibition and Excise portfolio, holding him "responsible" for the episode.

He accused the ruling DMK of "not being so bothered" about the issue of "increased availability" of ganja and illicit arrack in the last three years and "this has led to a big suspicion." "Due to this carelessness of the DMK Government, we have lost 60 lives to illicit arrack in Kallakurichi. Today, we met Governor R N Ravi seeking a CBI enquiry to probe who is behind the sale of illicit arrack," Annamalai said.

Further, the CM had not taken any action against Minister Muthusamy "despite so many loss of lives" which has led to

many questions among the people, he said.

"We also requested the Governor to insist to the Chief Minister to remove the Prohibition and Excise Minister," Annamalai added.

The BJP delegation included former TN BJP chief and ex-Governor of Telangana, Tamilisai Soundararajan.

Meanwhile, AIADMK General Secretary Edappadi K Palaniswami on Monday said that Tamil Nadu Chief Minister M K Stalin has an obligation to give an explanation for the spurious liquor tragedy in

Kallakurichi that claimed over 50 lives and said "time will soon come" for the Chief Minister to reply. Leading a massive State-wide protest against the ruling DMK dispensation from here, Palaniswami, a former Chief Minister, said the people's state of disorder and the turbulent scenes being witnessed in Karunapuram over the distilling and sale of spurious liquor, deserved a response from the Chief Minister.

He said his party cadres were prevented throughout Tamil Nadu from participating in the protests.

1,500 families evicted from Govt land in Assam

MORIGAON (Assam), June 24 (PTI)

AROUND 1,500 families who had settled illegally on forest and railway land have been asked to clear the area in Assam's Morigaon district.

The families, comprising around 10,000 people, had settled on Government land in Silbhanga village in Jagriroad, District Commissioner Devashish Sarma told reporters here.

"A notice was served to the people of the area on June 12 asking them to clear the land within ten days, and most of them have complied," he said.

Some families have children who are appearing for differ-

ent examinations. They have asked for more time, and "as a humanitarian gesture, we have decided to make arrangements for their stay till the exams are over," Sarma added.

"The administration is keen to ensure the clearance of the land without the use of force or demolition of structures. We held talks with the people, and they have agreed to do so with nearly 80 per cent of them already shifting their belongings from the encroached land," Sarma said.

Sarma visited the area during the day to ensure no untoward incidents took place. Security forces have also been deployed.

Atishi vows to continue fast until Haryana releases Delhi's share of water

NEW DELHI, June 24 (PTI)

WATER Minister Atishi said she would continue her indefinite hunger strike, which entered the fourth day on Monday, despite adverse health effects until Haryana released the "rightful share of Delhi's water."

"My blood pressure and sugar levels are dropping and my weight has gone down. Ketone level is very high which can have harmful effects in the long run. No matter how much my body suffers, I will continue the fast till Haryana releases water," she said.

The Delhi Minister said she was medically examined by doctors on Sunday. The Minister claimed Haryana has reduced Delhi's share in

Yamuna water by 100 million gallons per day (MGD) for the last three weeks.

The 100 MGD less water has caused a shortage, affecting 28 lakh people in Delhi, she said.

Delhi Lieutenant Governor VK Saxena after a meeting with the AAP delegation on Sunday said Haryana Chief Minister Nayab Singh Saini has assured to look into whether his state can provide extra water to the city. Meanwhile, Delhi Cabinet Ministers have written a letter to Prime Narendra Modi and urged him to resolve the water crisis in the national capital on a priority basis.

Addressing a press conference, Delhi Cabinet Ministers said Atishi's indefinite fast has entered the fourth day and her

health is deteriorating.

The Ministers held a meeting at the hunger strike site in Jangpura's Bhogal, where they decided to write a letter to the Prime Minister seeking a solution to the issue.

"We also invite Delhi Lt Governor V K Saxena, all officers to Wazirabad, Bawana to see the readings of flow metres and see the water levels of the river there. Data is available for the water released by Haryana and they can see for themselves how the water has reduced," he said.

Asserting that Delhi should get its due share of water, the Minister announced that in the evening, a candle light march will be carried out in support of Atishi's indefinite fast.

Haryana CM announces hike in income limit for creamy layer of OBC to Rs 8 lakh

CHANDIGARH, June 24 (PTI)

MAINTAINING that it will provide "significant benefits" in employment for the OBC category, Haryana Chief Minister Nayab Singh Saini on Sunday announced an increase in annual income limit for creamy layer from Rs 6 lakh to Rs 8 lakh.

Saini was addressing a gathering at 'OBC Morcha Sarv Samaj Samrasta Sammelan' held in Gurugram.

The move comes months before Haryana Assembly polls likely to be held in October.

"With the key aim of ensuring the welfare of the OBC community in Haryana and providing substantial benefits to the youth in Government jobs, Haryana Chief Minister Nayab Singh today made a series of pivotal announce-

ments," an official statement said.

The Chief Minister also announced that the reservation for the backward classes in Group-A and Group-B posts, currently at 15 per cent, will be increased to 27 per cent, "in line with the Central Government's policy." Besides this, the backlog of vacancies for backward class in Group-A and B category jobs will be filled on a priority basis, with preparations underway for a special recruitment drive, he said.

While speaking as the chief guest at the event, Saini announced that the annual income limit for creamy layer which currently is Rs 6 lakh has now been increased to Rs 8 lakh. The move will provide significant benefits in employment for the OBC community,

he said, as per the statement.

The CM said that this increased limit will be implemented in state Government jobs. Saini said it is a matter of pride that Prime Minister Narendra Modi is fully vigilant about protecting the interests of the OBC community.

The CM said that over the past 10 years, the Government has fulfilled its responsibility to benefit the OBC community at every level in Haryana.

Saini also said the Haryana Government is supporting the education of OBC children by providing scholarships ranging from Rs 12,000 to Rs 20,000 to ensure quality education.

The Government is also focusing on the skill development of the OBC community, he said.

CAG inaugurates India's 1st audit heritage museum in Shimla

THE Comptroller and Auditor General of India inaugurated the 'Chadwick House: Navigating Audit Heritage' Museum at Shimla on Monday, marking a significant milestone in the preservation and celebration of the institution's rich heritage and contributions to the nation's governance.

The museum, located at Chadwick House, has been developed into a state-of-the-art facility that showcases the evolution, achievements, and milestones of the institution of CAG. Chadwick House, a significant landmark in Shimla, boasts a rich

and extensive history. Its historical significance is further highlighted by Mahatma Gandhi's stay in 1946 during his visit to Shimla for the Cabinet Mission.

Post-Independence, in 1950, a training school for the Indian Audit and Accounts Service was started here. With the training

establishment moving, Chadwick House gradually fell into disrepair. Without proper care and maintenance, it was on the brink of demolition in 2018.

At that juncture, the Supreme Audit Institution of India stepped in to safeguard its heritage.

74 pc Indians back taxing super-rich to address global inequality, climate change, shows survey

NEW DELHI, June 24 (PTI)

AS G20 Finance Ministers prepare to consider a wealth tax on the super-rich next month, a survey has revealed that 68 per cent of people in these countries, including 74 per cent in India, support the idea to address global hunger, inequality and climate crisis.

The survey by the Earth4All initiative and Global Commons Alliance covered 22,000 citizens in the world's largest economies.

The proposal for a levy on the super-rich has been under discussion since at least 2013 with international support on the issue growing over the years. Brazil, the current President of the G20, aims to build consensus on the taxation of wealth and is likely to push for a joint declaration at a meeting of G20 Finance Ministers in July.

Gabriel Zucman, a French economist and a key influencer behind Brazil's G20 proposal for progressive interna-

tional taxation to promote tax justice, will release a report on Tuesday, outlining how "a global minimum tax on the ultra-rich" could work and how much it could raise.

According to Zucman, the super-rich pay significantly less tax than the ordinary people. The proposal aims to establish a new international standard: Billionaires in every country would be required to pay at least 2 per cent of their wealth in taxes annually.

Owen Gaffney, co-lead of Earth4All, said, "Indians want a giant leap on climate and nature -- 68 per cent demand dramatic reforms across all economic sectors within the next decade. This is a strong mandate for planetary stewardship that cannot be ignored." Seventy-four per cent of Indians support taxing wealth. Tax on high incomes and corporations to fund climate initiatives alongside a 'polluter pays' approach with income redistribution are also strongly supported, he said.

Citing lack of justification for maximum penalty, HC reduces lifer in POC SO case

BENGALURU, June 24 (PTI)

THE Karnataka High Court has reduced the sentence of an accused in a POC SO Act case from life imprisonment to 10 years, emphasising the need for valid reasons when imposing the maximum penalty. The accused, a 27-year-old man from Chikkamagaluru, had his appeal partially allowed by a division bench consisting of Justices Sreenivas Harish Kumar and C M Joshi. However, the court increased his fine from Rs 5,000 to Rs 25,000.

On June 11, 2018, a special court in the district headquarters town of Chikkamagaluru sentenced the accused to life imprisonment under Section 6 of the POC SO Act and imposed a Rs 5,000 fine after finding him guilty.
