RUSSIA'S NUCLEAR FORCES ON ALERT TO WEST'S THREAT: PUTIN

MOSCOW

RUSSIAN President Vladimir Putin on Thursday warned his nuclear forces were "always" on alert and added that Moscow would not tolerate any Western threats, during an address on the annual Victory Day parade.

Square before thousands of soldiers dressed in ceremonial attire, Putin heaped praise on his army fighting in Ukraine and accused "Western elites" of fomenting conflicts around the world.

"Russia will do everything to prevent a global clash, but at the same time we will not allow anyone to threaten us. Our

strategic forces are always on alert," Putin told the crowd. "Dear friends, Russia is now going through a difficult, crucial period. The fate of the Motherland, its future depends on each of us," he said.

The May 9 parade marks the Soviet Union's defeat of Nazi Germany in World War II and has become Russia's most im-

portant public holiday as Putin puts the country firmly on a combat footing.

Putin has used nuclear rhetoric throughout the conflict but has grown increasingly belligerent since last year, pulling out of a nuclear test ban treaty and a key arms reduction agreement with the United States. Earlier this week, he or-

dered the Russian military to hold nuclear drills involving the navy and troops based near Ukraine, raising fears he could use the powerful weapons on the battlefield. Putin has turned the Victory day into a pillar of his nearly quarter-century in power and a justification of his move into Ukraine.

Even though few veterans of

what Russia calls the Great Patriotic War are still alive 79 years after Berlin fell to the Red Army, the victory over Nazi Germany remains the most important and widely revered symbol of the country's prowess and a key element of national identity. Thursday's festivities across Russia, led by Putin who this week began his

fifth term in office. The Soviet Union lost about 27 million people in the war, an estimate that many historians consider conservative, scarring virtually every family.

Since coming to power on the last day of 1999, he has made May 9 an important part of his agenda, featuring displays of military might. AP/AFP

Israeli jets bomb Rafah despite US warnings

Netanyahu says his country will stand alone in its war against Hamas

SMOKE rose from strikes on Gaza's crowded southern city of Rafah Thursday after US President Joe Biden vowed to stop supplying artillery shells and other weapons to Israel if a full-scale offensive into the city goes ahead.

It was the starkest warning yet from the United States, Israel's main military provider, over the civilian impact of its war against Hamas Palestinian militants.

An AFP correspondent and witnesses on Thursday reported strikes on several parts of Rafah, where the United Nations said 1.4 million people were sheltering.

"The tanks and jets are striking," Tarek Bahlul said on a deserted Rafah street. "Every minute you hear a rocket and you don't know where it will land." Israel has already defied international objections by sending in tanks and conducting what it called "targeted raids" in eastern Rafah, the city it says is home to Hamas's last remaining battalions.

In an interview with CNN on Wednesday, Biden warned he would stop some US weapons supplies to Israel if it carried out its long-threatened major Rafah ground offensive.

Israel on Thursday called Bi-

den's comments "very disappointing". Biden told CNN: "If they go into Rafah, I'm not supplying the weapons that have been used... to deal with the cities... We're not gonna supply the weapons and the artillery shells that have been used."

But Israeli Prime Minister Benjamin Netanyahu appeared defiant. "If we have to stand alone, we will stand alone. If we need to, we will fight with our fingernails. But we have much more than fingernails," he said.

Asked about Israel's action already in Rafah, Biden said "they haven't gone in the population centres".

Ties between the allies have become increasingly strained as Biden and other top Washington officials criticise Israel over its conduct of the war.

Israel's military spokesman Rear Admiral Daniel Hagari was asked at a news conference whether the army can conduct the operation without the US arms. "The army has armaments for the missions it plans, and for the missions in Rafah too, we have what we need," Hagari said.

The United Nations agency for Palestinian refugees, UNRWA, said Thursday 80,000 people have fled Rafah since Monday, but "nowhere is safe". AP
