first things he plans to do post-retirement: "Food. Oh man, when I retire, I'm going to smash all of them! I'm quite regimental in the way I eat but I'm just going to let it go for five to ten days. I'm going for everything but especially the Indian dish of Aloo Paratha," Chhetri told FIFA.com

Reflecting on his decision to retire, Chhetri explained how he came to this pivotal moment, "I think it was a month after the last World Cup qualifier we played against Afghanistan, it started with a feeling, an instinct. Then I worked backwards towards it, why I'm feeling it and things like that. Eventually, it took me a month to come to the conclusion that this is it. This is the time that I should leave."

"In the build-up to that, a lot of things came into my mind. I think it's time for a new era of Indian football to start," he

Spain cruises past Andorra in **Euros warm-up**

MADRID: The Spanish national team began their preparation for the forthcoming European Championships a comfortable 5-0 win against Andorra.

Spain was sluggish in the first half but impressed as their rivals were tired in the second half, with Mikel Oyarzabal scoring a hat-trick.

The Spanish team will face Northern Ireland in another preparation game on Saturday. This match is crucial as coach Luis de la Fuente must cut his squad from 29 down to the 26 permitted in Germany, meaning it was the only chance for players such as Fermin Lopez, Aleix Garcia, Ayoze Perez, and Dani Vivian to impress.

A much-changed Spain side controlled nearly all of the ball but lacked cohesion to create many chances against a well-organized Andorra defense as the visitors worked hard to close down any spaces.

The first goal came from a corner when Pau Cubarsi nodded the ball down at the far post. Ayoze Perez still had work to do as he received the ball with his back to goal, but the forward was able to turn and score with a pow-

Meanwhile, Pool A is made up of the Netherlands, Germany, Great Britain, Spain, South Africa, and hosts France, setting the stage for an intense battle in the 12-team men's hockey tournament at the Paris 2024 Olympics.

Andreeva's remarkable resilience and strategic play culminated in a 6-7 (5-7), 6-4, 6-4 victory, making her the youngest Slam semifinalist since Martina Hingis in 1997.

BRIDGETOWN: In a spectacular display of allround brilliance, Marcus Stoinis led Australia to a commanding 39-run victory over Oman at the Kensington Oval in Barbados, marking a strong start to their World Cup campaign

on Thursday. Stoinis etched his name in the history books by becoming only the third player, after Dwayne Bravo and Shane Watson, to score a half-century and take three or more wickets in a men's T20 World Cup game. His heroics were the cornerstone of Australia's triumph on a tricky pitch.

Opting to bat first, Australia faced initial struggles on the sluggish surface. Tra-

This over alone yielded 26 runs, transforming Australia's fortunes and propelling them to a competitive total of 164. Warner played a crucial supporting role, scoring a patient 56, while Stoinis remained unbeaten with a

blistering 67 off 36 balls.
