# 'Ensure deployment of local officials for hassle free crop loan disbursement'

**Guardian Minister requests in memorandum sent to Union Finance Minister**

**Chandrapur 26 June:**

Currently, Kharif season is underway in the state. This season is very important for farmers and farmers are in dire need of crop loan for seeds, fertilisers etc. However, some nationalised banks in the district have bank officers from foreign countries, especially from South India, which creates difficulties in communicating with local farmers. The matter was brought to the notice of the state minister for forests, cultural affairs, fisheries and district guardian minister Sudhir Mungantiwar. Therefore, Guardian Minister Mungantiwar has written a letter to Union Finance Minister Nirmala Sitharaman on priority and requested to provide a bank officer who knows the local language to facilitate the crop loan disbursement process. Chandrapur, Gadchiroli, Gondia, Nandurbar districts of the state are known as remote. There is a shortage of bank managers and timely distribution of crop loans to farmers is a challenge. Also, in some banks, bank managers from other states, especially from South India, are appointed, so they



language and are associated with the local culture are deployed in district's banks, the overall banking system will run effectively.

The special thing in this concern is that the farmers can easily communicate with such officials in their local language and share their problems. Marathi bank officials know what the local citizens need, what are the problems regarding disbursement of crop loans. Therefore, the appointment of such Marathi officials will help the banking system here to run in a more effective manner, Guardian Minister Sudhir Mungantiwar has mentioned in a memorandum written to Union Finance Minister Nirmala Sitharaman in this concern.
