Sreeja Akula makes history with double gold

encounter

NIGERIA: Indian table tennis star Sreeja Akula made history by clinching both the women's singles and doubles titles at the WTT Contender Lagos 2024, held at the Sir Molade Okoya Thomas Indoor Sports Hall.

The 25-year-old Akula, a member of India's table tennis contingent for the upcoming Paris 2024 Olympics, triumphed over China's 16-year-old Yijie Ding with a commanding 4-1 victory (10-12, 11-9, 11-6, 11-8, 11-6) in the singles final.

This win marked a significant milestone for Indian table tennis, as Akula became the first player from the country to secure a WTT Contender singles title. In the semifinals, Akula had earlier defeated her compatriot and Tokyo Olympian Sutirtha Mukherjee in a closely contested match, prevailing 3-2 (11-8, 13-15, 11-9, 9-11, 12-10). Sutirtha had herself advanced by overcoming defending champion and world No. 8 Shin Yubin of South Korea 3-2 (11-9, 3-11, 0-11, 11-9,

11-6) in a thrilling quarterfinal 11-8). In the men's doubles final, national champion Har-



In the doubles category, Akula partnered with Archana Kamath to secure another gold for India, defeating Yashaswini Ghorpade and Diya Chitale 3-2 (11-9, 11-6, 12-10) in an all-Indian final showdown. Meanwhile, India's top-ranked women's player Manika Batra, ranked 28th globally, faced an unexpected defeat in the round of 16 against Egypt's Farida Badawy, ranked 331st, losing 3-2 (11-8, 11-9, 8-11, 9-11, title at a WTT Contender event with a 3-0 (11-8, 11-9,

11-8) victory. All four Indian players who clinched titles - Sreeja Akula, Archana Kamath, Harmeet Desai, and Manav Thakkar are part of India's contingent for the Paris Olympics.

SA beat Windies

ANTIGUA: In classic fashion, the Proteas navigated a nail-biter at the ICC Men's T20 World Cup, advancing to the knockout stages with an unblemished record on Monday India time. South Africa edged out a resilient West Indies team, clinching victory with five balls to spare despite a dwindling lineup.

The Proteas largely dominated the must-win clash from the start, choosing to field first at Sir Vivian Richards Stadium. Aiden Markram gave Marco Jansen the new ball, and Jansen delivered immediately, dismissing Shai Hope for a first-ball duck. Markram then tempted Nicholas Pooran into a mistimed shot, well-caught by Jansen.

Jansen nearly had a second wicket, but Anrich Nortje dropped a tough catch off Roston Chase.

Chase capitalised on this chance, partnering with Kyle Mayers to rally during the Powerplay.

By the six-over mark, the West Indies had reached 47/2, capped by a six from Mayers. A costly collision between Jansen and Kagiso Rabada on the boundary in the eighth over halted play and saw Jansen leave the field for assessment. Despite this, Mayers and Chase pushed the score to 62/2 off 10 overs, shifting momentum to the hosts.

In the men's category, India and China secured quotas while in the women's category, Indonesia joined India as the second country to secure team quota.



Industrialists expecting relief on tax

PUNE: Ahead of Union Budget, which will presented in July after the formation of a new BJP-led NDA government at the centre, Pune industrialists are expecting relief from tax and a reduction in the rates of GST.

In view of the upcoming budget, industrialists have started to put their demands before the government. The meeting of the Goods and Services Tax (GST) Council under the chairmanship of Finance Minister Nirmala Sitharaman is taking place at the national capital, Delhi, where discussion on simplifying GST and reducing rates in many sectors is possible, said Rajesh Agarwal, held in October 2023, he

said. Agarwal said that in view of the high rate of inflation in the upcoming full budget 2024-25, the government needs to consider relief for people in the lowest slab of income tax. At the same time, the process of tax simplification should

continue. He further said that we are seeking a review of the 43B(H) Act, which has been imposed on registered traders of micro, medium, and small enterprises (MSMEs) since this year. It requires traders to pay for goods purchased within 45 days. But the traders are asking for 90 days for payment. The trad-
